CHANCELLOR'S REPORT

Chancellor's Communications

Chancellor Isaac commented on the following:

- The Baccalaureate degree at California Community Colleges (CCC) is increasingly being recognized as a matter of equity.
 - Data shows students with a baccalaureate degree earn twice as much as they did with a certificate of an associate degree.
 - With the signing of AB927, Baccalaureate degree offerings at CCC is rapidly expanding.
 As of today, there are 33 programs with five of which, are still under review.
 - RCCD will be looking at initiating a number of programs for whom we have both the staff and the facilities, and where the program has already been developed.
 - Thanks to Senator Richard Roth, this year, we are working together with other community colleges to introduce AB895, allowing a pilot phase for a Bachelor's of Science in Nursing.
- The Joint Board meetings with our service area unified school districts is growing stronger with a much greater focus and energy.
 - Thanked faculty, management, and classified professionals, for their diligent efforts in strengthening these vital relationships.
- Plans to coordinate a Joint Board meeting with Riverside County Office of Education and RCCD per the suggestion from Board President Alcala.
- Propose to organize an annual event with the objective of bringing together representatives from UCR, and CSUSB, along with all the service area unified school district Boards. The aim of the event is to collectively evaluate the totality of the educational programs together.
- In February, the Chancellor, Board President Alcala, and Trustee Then, will be attending the CCLC Annual Legislative Conference in Sacramento and the ACCT Legislative Summit in Washington D.C. They will by lobbying for AB895, Mapping Articulated Pathways (MAP), Credit for Prior Learning, and IETTC will be the main theme for lobbying to members of congress,

- senators, and congressmen.
- Ofelia Valdez Yeager's Memorial Services is Friday, January 26, 10:00 a.m. at St. Francis De Sales Catholic Church in Riverside.
- Per the State Chancellor's Office, only 38% of CCC are utilizing the PELL grant. Therefore, with the millions of dollars available, we need to ensure students have access to use these funds like student aid.
