II. Update on Early Registration & Information Technology Workgroup – Susan Mills and Heather Edberg

- Issues with the summer/fall registration model is in getting everything entered into curriculum, allowing ample time for IDS' to input, the workload to creative services, and the reviews necessary at the colleges. The time line will be very tight.
- The idea was that adding the ability to view sections by April 8 would give the students more time to plan

- The original publish date was on April 16th but was moved to April 24th. This will give students more time to view the schedule.
- Catalog will be published on March 29, 2019. Curricular changes went to Teaching and Learning two days ago, they will then be voted on
 next week. This will be the cut off for catalog, everything thereafter will go on the addenda.
- Program maps are developed to align with the catalog. A current practice at the colleges is for program maps to publish simultaneously with the catalog. This also affects what's in EduNav because of the smart rules set in place. There is some conversation about the program review process having each discipline regularly review their program maps.
- The other piece of the timeline is the difficulty with MIS reporting, essentially the end dates. Fall and winter will be ok, spring will be challenging due to the reporting period. This will need to be coordinated among the colleges with the Coordinators and Ed. Services.

Update on the Role of RCCD Enrollment Management Committee – Dyrell Foster

- The focus has been on retention in Enrollment Management. In the data collected from Moreno Valley College, there are a number of students with outstanding balances preventing them from enrolling.
- The most common balance seen was around \$40.50 which was made up of the student services fee, transportation fee and Student health fees.

- Many of these students are part of the Promise Grant that covers tuition but not those additional fees. There needs to be a threshold in place for fees to allow for registration.
- Reporting at the end of October showed that 3,000 students at Moreno Valley College were unable to register because of fees, 70% of these
 students owed a fee of less than \$100.00.
- One of the other pieces is many of these students receive financial aid, for example the Pell Grant. The current practice is to give the student the full disbursement of the grant without subtracting fees owed. Students are confused when they receive the grant and are then responsible for these additional fees. The long-term solution would be to change the financial aid system to automatically deduct the fees. Will work on getting a district wide number for how many students are carrying these fees impacting registration. Run the query for data
- This threshold is not going to be set in place just for financial aid students.

Aaron Brown recommends this discussion be brought before DSPC with the following data and analysis: How many students are affected by this at each college? How many of these students are on the Pell Grant? What is the financial impact of these fees not being paid to Student Services? How do the numbers equate to FTES?

III. Vice Chancellor, Educational Services and Strategic Planning Report – Susan Mills

- Update on the role of the RCCD Enrollment Management Committee
 - As we continue to work through the District Strategic Plan our role is going to continue to be more than FTES. There will be many other things such as the taskforce Aaron Brown will be forming, data/research, Guided Pathways among other projects.
- Report from the scaling Guided Districtwide Institute
 - Talked about enrollment management and how we are able to do a better job as a District at figuring out our course offerings, scheduling and sections offered?
 - o For example, COM-20 not offered at MVC, Organic Chemistry cannot be offered at MVC, Psych-50 only at RCC
 - Math 12 had the highest failure rate. Data sets are available, however, we have to figure out what questions to ask. That will establish a baseline on what happened previously.
 - We need to have agreement and a clear conversation. DECM will create a proposal and bring it to Strategic Planning. The discussion is to include shortfalls, hitting/exceeding targets.
 - A meeting should be set and include Chancellor, College Presidents, VPAA(s), CBO(s), VC(s) Brown and Mills as soon as possible to go over the numbers, rollback and potential growth.
