II. Update on Scheduling Task Force

EduNav will be hosting a meeting to bring EduNav users from other colleges together and illustrate how they are leveraging and implementing the EduNav systems and data. The RCCD team has been invited to attend and collaborate with other EduNav college users. The first meeting will focus on data and the second meeting will be geared towards strategizing data-driven on-campus decisions.
