- Classroom Active Shooter Preparedness and Response Document
 - Bold changes and the addition of "labs" were incorporated into the revised document. The document will be submitted to Chancellor's Cabinet after all of the approval signatures are received on the new shared governance routing document. Once approved by CC, the document will be released to the Colleges for implementation.
- Committee Member Update
 - Committee will require student representation at the start of the new semester.

 Committee members with responsibility to identify student representatives to provide approximate date for notification to the committee chair.

 Risk Management approached the CSEA President to identify a temporary substitute for Gary Storer until he returns. Awaiting response.
 Risk Management requested a replacement for Cecilia Alvarado in the role of RCC Student Discipline Officer to the committee. Awaiting response from Dr. FeRita Carter.
Shared Governance Work Flow Chart and Approval Tracking Document
• The routing form and work flow for the approval of DSSC initiatives have been updated. A sample of the form and work flow will be provided to the group for review and feedback. The Classroom Active Shooter Preparedness document is the first initiative to move through the new process.
Door Lock Initiative and Board Policy Draft Discussion
 Update provided by the individual College Safety Coordinators. Update on the development of videos to support notifications to all stakeholders. Will include discussion about video development for other areas of threat, i.e., earthquake, fire, etc.
Emergency Communications Protocol Flip Chart
 Document will undergo revisions through the newly formed Strategic Communications / Risk Management working group.
BP/AP Regarding Police Response to Immigration Incursions
 Discussion to confirm committee's receipt of the drafted document and identify a proposed date for final reading with the group prior to submission to Chancellor's Cabinet or DSPC.

Police Policy Manual Discussion
Policy Manual is under review. Expect update on progress at the September meeting.
• Semester_Safety_Briefings_(students,_faculty,_and_staff)
 Risk Management provided the weapons free zone statement to the DSSC for review. Discussion needed to confirm transfer of the policy statement in support of BP3530 to the faculty association and introduction of the statement to the CSEA. Committee to assign leadership, accountability, and timelines for the development of all briefings to students and staff.
Active Shooter Training
 The four-part Active Shooter presentation / training is still in progress. Risk Management will share the presentation at the September 2018 meeting. JPA is standing by to transform the presentation into training format.
Community College "Target Hardening" Initiatives Proposal
 Risk Management to provide an update on the development of a "Target Hardening" Initiative. The initiative is designed to generate discussion and direction from the Chancellor and the DSSC related to recommended actions RCCD can take to make the colleges and District office harder to attack.
• Qne Button Lock Out Initiative
 Update provided by the Safety Coordinators on the development of a list of areas of concern and a priority list to identify project structure.
