Reports from Colleges

- 1. Moreno Valley
 - a. ECON, AHS, and HIS faculty are working on the CCN courses for Phase 2A. The committee also discussed the FSA and origination permissions issue. The consensus was that if there is a full-time faculty member in the District with the FSA, that person should have the origination permissions for the discipline. If there are no such faculty, origination permissions can go to faculty with secondary FSAs. What do we do if there is no one with the secondary FSAs?



- i. Kelly Douglass As Brian Johnson suggested, we should question why we have the discipline if no one is hired to teach it.
- ii. Nick Sinigaglia What do we do when faculty want to develop a new program? At times you can't hire faculty until you have the courses, but you can't have the courses until you have the faculty.
- iii. Kelly Douglass There may be times where need to have a temporary exception.
- iv. Nick Sinigaglia There may also be faculty in unique positions due to how the discipline has changed over time.
- v. Kelly Douglass The contract allows for transferring from one discipline to another, but unclear how to address this at the curriculum level.

2. Norco

a. The Norco committee discussed the work experience courses and how they need to be updated. We also discussed the permissions and origination list. The consensus was that if you do not have the FSA that you should not have the origination permissions at all.

3. Riverside

a. At Riverside, we discussed that the role is of the originator and the co-contributor. Kelly has discussed the topic with the VPAA at Riverside and discussions will continue in the fall.

 - a. The committee agreed that items from today's meeting would be scheduled for the September Board of Trustees meeting.

2. Open Forum

- a. Nick Sinigaglia At Moreno Valley, there are a number of courses that faculty do not intend to offer, but they want to keep them in the catalog for the purpose of credit for prior learning.
 - i. Eric Bishop Courses do need to be regularly reviewed for accreditation.
 - ii. Kelly Douglass Faculty should review the BP/AP for Credit for Prior Learning to see if the process requires that the courses exist in the catalog.
- 3. Public Comment for all items on or not otherwise on the agenda.
 - a. Eric Bishop The committee may want to consider how Tech Review and DCC are scheduled moving forward to adhere to the Brown Act. Tech Review usually ends early, but the public may have the expectation that DCC begins at 4:00pm. Can Tech Review and DCC be scheduled as a single meeting?
 - i. The committee discussed that the Tech Review and DCC voting constituency and chairs are not the same. Additionally, guests typically attend Tech Review and not DCC, so a specific start time for Tech Review is important. One solution may be scheduling Tech Review to end at 3:30 in the spring and beginning DCC at that time.
 - ii. Eric Bishop will meet with Keith Dobyns to see if there are other options.
