# PROFESSIONAL GROWTH AND SABBATICAL LEAVE COMMITTEE

I. Approval of October 2, 2014 Minutes/Miter/Gobatie/(vote: 1 aye/3 abstentions)

Motion Defeated - deferred until next meeting.

#### II. Information Only

AP 7160a has been approved and will be uploaded to the web soon.

**Professional Growth Credit** for publications, textbooks, articles, and compilations - Cyndi Gobatie is submitting her observations for a rubric. Overall, Cyndi felt it would be ill advised to create any kind of stringent rubric due to the rare occurrence of a salary reclassification based on publications.

 Celia stated that she agrees with the majority of Cyndi's guidelines. However, she doesn't believe that a published book should be granted the same amount of units as a long article. She thinks a published book should receive more or a long article less.

**Discussion** followed. The committee agreed that the language in AP 7160a regarding the maximum amount of allowable credit for publications and independent study should be changed from five maximum units to 7-10 units. During the previous revision process of AP 7160a, the committee had changed the maximum number of units to seven but then decided to change back to five units so as not to hold up the approval process by the Senate. The committee had stated instead that maybe a rubric was needed and agreed to provide research on creating a rubric by the next meeting. The committee had stated that a rubric could be a link provided in the AP document.

Tammy will write up a request to present to the District Senate President explaining why PG & SL feels it's necessary to make the above changes to AP 7160a in hopes that this request will be submitted as an agenda item to District Senate.

#### III. Professional Growth

**Ladylyn Dominguez** – is an Assistant Professor of Counseling at Norco. She is requesting professional growth for a three unit online graduate course through University of Wisconsin Platteville starting on January 26, 2015 – May 1, 2015:
