- WHEREAS,** Trustee Green is a recipient of the American Business Woman of the Year, Air Force Nurse of Western Pennsylvania, Caring Nurse Award, and ASRCC Excellence Award; and
- WHEREAS,** her successful career included serving as an administrator and professor at San Bernardino Valley College, administrator at Riverside General Hospital and nurse in the US Air Force; and
- WHEREAS,** the Governor of California appointed her to the Emergency Medical Services Advisory Committee, the State Bar Board of Governance, and the State Bar Foundation.
