

**RESOLUTION OF THE BOARD OF TRUSTEES OF THE RIVERSIDE  
COMMUNITY COLLEGE DISTRICT IN SUPPORT OF  
MEASURE X FOR MORENO VALLEY SCHOOLS****RESOLUTION NO. 32 – 24/25**

**WHEREAS**, Riverside Community College District is committed to the safety and success of local students in Moreno Valley; and

**WHEREAS**, Proposition 2, the Kindergarten Through Grade 12 Schools and Local Community College Public Education Facilities, Modernization, Repair, and Safety Bond Act of 2024, provides \$10 billion for education financing for constructing new classrooms to accommodate growth and provide job training, repairing health and safety issues, renovating facilities, and equipping learning spaces with essential technology; and

**WHEREAS**, many of our neighborhood schools were built 30-60 years ago and require priority repairs and updates to support high-quality instruction in science, technology, engineering, arts, and math; and

**WHEREAS**, student safety and security systems need to be updated and replaced, including fencing, cameras, fire alarms, and sprinklers; and

**WHEREAS**, if we want our students to succeed in college and their future careers, they must be skilled in the use of today's technology and have advanced courses in science, math, and engineering; and

**WHEREAS**, since affordable higher education focused on high-demand, good-paying careers is one of the best ways for people to lift themselves up out of poverty, this proposed measure will help provide cleaner, safer, healthier and more up-to-date community colleges, retain and attract quality educators and provide 21st century learning so the people of our community have access to the tools they need to be successful in life; and

**WHEREAS**, 100% of all money raised by Measure X stays here for our schools, it cannot be taken by the state; and will help our schools qualify for \$100 million in state matching funds that would otherwise go to other communities; and

**WHEREAS**, Riverside Community College District supports these important improvements for our local schools:

1. Repairing deteriorating roofs, plumbing, and electrical systems
2. Updating classrooms and educational technology
3. Improving science labs and equipment to prepare students for college and in-demand careers

4. Upgrading older schools and replace portables to meet today's health and safety codes
5. Ensuring proper access for students and community members with disabilities; and


**WHEREAS**, Measure X is transparent and accountable, requiring public disclosure of spending and independent financial audits; and

**WHEREAS**, 100% of Measure X funds will remain here under local control and cannot be diverted by the State; and

**WHEREAS**, Measure X will not increase tax rates.

**NOW, THEREFORE BE IT RESOLVED**, that the Board of Trustees of the Riverside Community College District supports Measure X on the November 5, 2024 ballot.
