Background Narrative:

The Riverside Community College District's Colleges has received additional funding for the 2025-2026 Mathematics, Engineering, Science Achievement (MESA) Grant in the amount of \$680,705 from the California Community Colleges Chancellor's office. The funding by college is as follows: Riverside City College - \$139,393, Norco College - \$410,656 and Moreno Valley College - \$130,656. The funds will be used for operational expenses of the program.
